

**Official Announcement to Authorized
Distributors of Aspire Global Inc. Products**

致 Aspire 授权经销商的通知函

Effective from today, in order to ensure compliance with applicable laws and government policies, all authorized distributors of Aspire Global Inc. (Aspire) products must comply with the following obligations:

为了确保遵守适用法规和政府政策，从即日起，Aspire 所有授权经销商均应履行以下义务：

1. Authorized distributors shall not sell or distribute Aspire products in countries where vaping products or Electronic Nicotine Delivery Systems (ENDS) are illegal. These countries include but are not limited to Singapore, Thailand, Sri Lanka, North Korea, Turkey, and Norway.

Aspire 授权经销商不得将 Aspire 产品销售或分销到电子烟或电子尼古丁传送系统（简称 ENDS）非法的国家。这些国家包括但不限于新加坡，泰国，斯里兰卡，朝鲜，土耳其，挪威等。

2. Authorized distributors shall not sell or distribute in (or import into) the United States any Aspire product that does not have a PMTA authorization.

Notwithstanding the foregoing, and until further notice, authorized distributors may continue to sell or distribute in (and import into) the United States those Aspire products subject to FDA's continued compliance policy during the Agency's review of Aspire's currently pending PMTAs. These products include only the following: Nautilus Prime, Nautilus 2S 0.7Ω Mesh coil, Nautilus BVC 1.6Ω coil, Nautilus BVC 1.8Ω coil, and Nautilus Prime pod.

Aspire 授权经销商不得在美国销售、分销(或进口) 任何没有提交注册 PMTA 的 Aspire 产品。尽管有上述规定, 在另行通知之前, 在 FDA 对 Aspire 已提交的 PMTA 审查期间, 授权经销商符合 FDA 的持续合规政策前提下, 仍可继续在美国销售、分销(进口) 以下 Aspire 产品, 这些产品仅包括: Nautilus Prime, Nautilus 2S 0.7 Ω 网状雾化芯, Nautilus BVC1.6 Ω 雾化芯, Nautilus BVC1.8 Ω 雾化芯, Nautilus Prime POD。

3. Authorized distributors shall not for any reason or under any circumstance whatsoever sell, market, or promote Aspire products to minors (i.e., those under 21 in the United States) or adult consumers who do not currently use tobacco or nicotine products.

授权经销商不得以任何理由或在任何情况下向未成年人销售(比如美国低于 21 岁的未成年人), 或是之前没有使用过烟草或尼古丁产品的成年人销售, 营销或推广 Aspire 产品。

4. Authorized distributors selling or promoting Aspire products in the United States must also comply with all other applicable statutes, regulations, and policies, including but not limited to those implemented and enforced by FDA.
